GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**Listing Rules**”).

The board of directors (“**Board**”) of BExcellent Group Holdings Limited (“**Company**”) hereby announces that the Company has granted the following share options (the “**Options**”) to subscribe for a total of 4,400,000 ordinary shares of HK\$0.01 each in the share capital of the Company (the “**Share(s)**”) to selected grantees (the “**Grantees**”), subject to acceptance of the Grantees and the payment of HK\$1 by each of the Grantees upon acceptance of the Options, under the share option scheme of the Company adopted on 21 June 2018 (“**Share Option Scheme**”). Details of the Options are set out as follows:

Exercise price of the Options granted	:	HK\$0.730 per Share
Total number of the Options granted	:	4,400,000 (each Option shall entitle the relevant Grantee to subscribe for one Share)
Closing price of the Share on the Date of Grant	:	HK\$0.700 per Share
The average closing price of the Shares for the five business days immediately preceding the Date of Grant:	:	HK\$0.730 per Share
Validity period of the Options	:	The validity period of the Options shall be ten (10) years from the Date of Grant (“Validity Period”) and the Options shall lapse at the expiry of the Validity Period or earlier if the service relationship between the Company and the respective Grantee of the Options has terminated prior to the expiry of the Validity Period, subject to the terms and conditions of the Share Option Scheme.

Vesting and exercisable period of the Options : The Options granted to each Grantee shall vest in and be exercisable by such grantee as follows:

- 30% of the Options shall vest on and be exercisable from the first anniversary of the Date of Grant;
- 30% of the Options shall vest on and be exercisable from the second anniversary of the Date of Grant; and
- 40% of the Options shall vest on and be exercisable from the third anniversary of the Date of Grant.

Among the 4,400,000 Options granted, (i) 1,000,000 Options were granted to the following director of the Company; and (ii) the remaining 3,400,000 Options were granted to the selected employees under the Share Option Scheme.

The grant of the 1,000,000 Options to the above director of the Company has been approved by the independent non-executive directors of the Company pursuant to Rule 17.04(1) of the Listing Rules.

Save as disclosed above, none of the Grantees is a director, chief executive or substantial shareholder of the Company or any of their respective associates (as defined under the Listing Rules).
